



# 2021 Valley Hi Country Club Memberships

## Proprietary Family Membership

**Initiation \$8,500**

**Dues: \$560 per month (Plus \$30 Capital Reserve Fund Monthly Fee)**

**Food & Beverage minimum: \$200 per quarter**

- Owns an equity interest in the assets of the club.
- Has the right to vote.
- Is eligible to hold any club office.
- May serve on club committees.
- 7 days in advance tee times
- No restrictions on Saturday tee times

Each Proprietary Member and their families have full use of the clubhouse, golf course, practice facilities and all other sponsored events and activities subject to the rules, duly adopted by the Board of Directors.

## Young Professional Membership (21 to 39 years of age)

**Initiation: \$3,500**

**Dues: \$341 ages 21-29 - 60% of the Proprietary Members monthly dues, plus \$30 Capital Dues**

**\$407 ages 30-39 - 70% of the Proprietary Members monthly dues, plus \$30 Capital Dues**

**Food & Beverage minimum: \$100 per quarter**

The Young Professional membership is a convertible membership available to individuals from the ages 21 to 39. Subject to specified conditions, a Young Professional member and his or her family may enjoy full privileges of the clubhouse, golf course, practice facilities and other Club sponsored events activities. The Young Professional is restricted to securing a tee time 7 days in advance. Young Professional Members will be charged monthly dues, fees and special assessments at a rate less than those paid by Proprietary Members as established by the Board of Directors. They will also be responsible for the payment of half the Club's established quarterly food and beverage minimums. Conversion to other available membership levels may be exercised any time prior to his or her fortieth (40) birthday. Upon conversion any previous initiation fee will be applied toward the current initiation fee for the desired new membership level.

## Family Social Membership

**Initiation; \$200**

**Dues: \$120 per month (includes Capital Reserve Fund Fee)**

**Food & Beverage minimum: \$200 per quarter**

Social Members, and their families, may enjoy the privileges of the clubhouse and the club sponsored social events. No golf access included

## Family Sport Social Membership

**Initiation; \$1000**

**Dues: \$350 per month (includes Capital Reserve Fund Fee)**

**Food & Beverage minimum: \$200 per quarter**

Sport Social Members shall have golf privileges limited to *two* (2) rounds a month. Play is restricted to after 11:00 am on weekend and holidays and during open play times Tuesday through

Friday. Sport Social Members, and their families, shall have full privileges of the clubhouse, pool, social events, and use of the practice facilities. Members are encouraged to entertain family members and guests with applicable guest fees and adhere to guest tee time policies; cart fees apply. Tee time reservations may be made 72 hours prior to desired tee time by calling the Pro Shop or using the Fore Tees service online. There is a 12 month maximum limit as a Sport Social Member.
